The Proposal Writing Workshop is designed for the doctoral student who plans to apply for external funding in the spring or fall 2009 semesters to support dissertation work (research and/or writing) during the 2009-2010 or 2010-2011 academic years. The workshop will take the student through the mechanics of writing a strong proposal for external funding. To participate in the workshop, each registered participant will need to complete and submit by 9:00am on Thursday, January 8, 2009 either our Proposal Writing Tutorial (which is available on the Fellowship Guide Sakai site-https://sakai.rutgers.edu/portal) or a proposal written for a specific funding competition. The workshop activities will include lecture, group discussions, group exercises and review and critique sessions. To participate, pre-registration is required by December 19, 2008.

Two first authors are allowed as long as both are graduate students. Authors of abstracts selected for oral/poster presentation will be notified by Friday, January 25th.

#### Abstract format:

- 1. Abstract must be no longer than 250 words. The text must be in size 12 Times New Roman font. A successful abstract will include a concise title, a purpose, hypothesis, results (with statistics, if applicable) and significance of findings. Preliminary results are acceptable.
- 2. Title of the abstract must be in bold, size 12 Times New Roman font. The first author(s) must be bolded. Advanced degrees of contributing authors must be indicated. The PI will be listed last, as senior author.

### Oral Presentation guidelines:

- 1. Presentations are limited to 10 -- 12 minutes, with 3 minutes put aside for questions from the audience. Presentations must be in PowerPoint format. Use of additional media (movies) is encouraged. Additional props will not be accepted nor will they be provided.
- 2. Three speakers will be awarded prizes. Oral presentations will be judged based on quality of speaker's presentation skills with special focus on presenter's ability to field questions based on poster.

Poster Presentation guidelines:

- 1. Posters must have the title of the abstract as well as all the authors, with the first author bolded.
- 2. Posters will be judged based on organization and content with special focus on presenter's ability to field questions based on poster.
